The ERC (Employee Retention Credit) is a \$800 billion dollar program that yields business owners a payroll and employee healthcare tax refund. It does not need to be paid back. You stand to receive up to \$26k per employee.

January 2021 modifications were buried in the headlines at the time loosening The ERC Federal COVID Relief program as follows:

- 1. Any COVID interruption counts (supply chain limitations, inability to work with vendors, shifting hours, loss of staff, increasing sanitation etc.), rather than a decrease in revenue.
- 2. The number of employees on payroll can be 5-500, during Q2, Q3, Q4 of 2020 and Q1, Q2, Q3 of 2021.
- 3. Companies who participated in the PPP loan program may also receive ERC.

The law does not define an interruption and therefore with proper representation, 94% of businesses are qualified. (Ex. 10 employees: up to \$260,000). There is already 400 billion accounted for by applicants and only \$700 billion left. Funds are limited and the IRS is backlogged, so it's important to act quickly.
